## **USE OF PROPANE GRILLS**

## Propane grills must be used outdoors only

- Propane grills should be placed at a safe distance of 10 ft. from the rear (kitchen side)
  of the unit. (<u>Etons</u> and <u>Greenbriars</u> without rear doors are able to place propane grills
  at the front of unit which is porch side.)
- For units that do not have a 10 ft. space between it and an adjoining unit or the curbside, then an exception could be granted. <u>Under no circumstances shall the distance between grill and structure be less than 5 ft.</u>
- Propane grills and tanks must be kept <u>outdoors</u> at the rear of the unit (kitchen side) even when not in use. An exception to this rule would be the Eton and Greenbriar models which do not have rear doors. They can store the grill on the porch side of their units.
- Empty tanks, if necessary, may be stored in the garage. The tank must be empty and the tank valve must be open.
- Please use sensible care and follow all of the manufacturer's directions for care, use and storage.
